



**Job Description: Sanitation Truck Operator**

Location: Street Shop

Department/Division: Solid Waste

Reports to: Public Works Manager

FLSA: Non-Exempt

Pay Range: 28

**Definition:** Under direct supervision picks up customer's garbage and recyclable; assists at transfer station.

**Essential Functions:** Essential functions, as defined under the Americans with Disabilities Act, may include the following tasks, knowledge, skills and other characteristics. This list is ILLUSTRATIVE ONLY, and is not a comprehensive listing of all functions and tasks performed by positions in this class.

**Tasks:**

- Picks up customers' garbage; occasionally operates garbage truck; picks up customers' recycling materials; separates recycling materials; occasionally drives recycling truck.
- Works on street crews driving dump trucks and operating loaders.
- Cleans and repairs curbs and gutters; assists with asphalt patching.
- Assists at transfer station, composting, and rubble site; sorts garbage from recycling materials; operates skid loaders and semi-trucks.
- Fills garbage trailers and recycling trailers; moves full transfer trailer and replaces with empty trailer.
- Regularly scheduled to work at Transfer Station on Saturday on a rotating schedule.
- Assist with snow removal operations during snow events.

**Knowledge, Skills and Other Characteristics:**

- Knowledge of EPA and state regulations related to solid waste disposal and recyclable.
- Knowledge of basic preventative maintenance on equipment.
- Skill in driving/operating a wide variety of heavy equipment and vehicles.
- Skill in loading, unloading and transporting garbage and recycling materials.
- Skill in inspecting a variety of vehicles utilized in the moving and transporting rubble and solid waste.
- Skill in sorting garbage and recyclable.
- Ability to manage scale house transactions.
- Skill in utilizing public relations techniques in responding to inquiries and complaints.



- Skill in the use of proper health and safety precautions when operating or working with power tools, cleaning/maintenance chemicals and hazardous/infectious waste.
- Skill following written and oral instructions.
- Skill in establishing cooperative work relationships with those contacted in the course of work.

**Environmental Conditions:** The following environmental conditions may exist while this person is performing their job task: dirt, dust, fumes, odors, excessive noise, wetness, humidity, welding flash, heat, cold, chemicals, and other unpleasant weather conditions.

**Qualifications:**

**Required qualifications to effectively perform the job. An equivalent combination of education, training and experience will be considered. (Additional requirements may be designated by position.)**

- High School Diploma or GED.
- Project supervisory duties and administrative experience
- Familiar with equipment operation.
- Ability to obtain Class B Commercial Drivers' License within six (6) months.
- One (1) year full time truck driving, solid waste collection, road construction or maintenance.

**Physical Qualifications:**

**Below are activities that are commonly associated with the performance of the functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform essential functions.**

- This will be medium work physically with exertion up to 50 pounds of force occasionally, and/or up to 10 pounds of force frequently.
- Regularly required to reach, stand, walk, push, pull, lift, finger, grasp, feel, talk, hear, have repetitive wrist, hand and/or finger movement.
- Occasionally required to climb, stoop, kneel, crouch, and/or crawl.



- Must have close visual acuity.

- Subject to both inside and outside environmental conditions including extreme cold and heat.
- Subject to noise and a loud work environment.

- Function around prisoners.
- May be required to wear a respirator.
- May be required to work in confined spaces with a wet and humid environment.
