AREA OF CONCERN:

Special Events Alcohol

Cost Comparison

City	Fee
Yankton	\$5/event
Mitchell	\$200/event or \$500/event with noise permit
Brookings	\$50/event
Watertown	\$300/event
Spearfish	\$50/day for malt bev or wine \$100/day for liquor

Application Process

- Currently use 2-sided State's Uniform Alcoholic Beverage Application but not required
- Recommend to streamline application process easier form

Communication

- No specific City Ordinance on Special Event policy
 - Can limit number of special alcohol licenses per calendar year per person/entity
 - Refer to SDCL 35-4-124
- Recommend to provide policy handout & FAQs to the public
