#### **Definition:**

Under the direction of the City Manager, serves as the chief administrative officer of the Police Department; coordinates law enforcement and other public safety activities; oversees the enforcement of all laws within legal jurisdiction; plans, coordinates, supervises all personnel and department programs.

# **Essential Functions:**

Essential functions, as defined under the Americans with Disabilities Act, may include the following tasks, knowledge, skills and other characteristics. This list is ILLUSTRATIVE ONLY, and is not a comprehensive listing of all functions and tasks performed by positions in this class.

### Tasks:

- Fulfills missions of the City of Yankton and Yankton Police Department
- Leads City's community orientated policing initiatives
- Plans, directs and coordinates the activities of the police department
- Directs and oversees supervision of police department personnel including patrol, investigations, administration, school resource, K-9, and community services
- Works closely with Information and Technology Services to purchase equipment and to implement and train staff to utilize technology
- Oversees and administers animal control and contracted animal services
- Controls expenditures of department appropriations and prepares budget
- Reviews and assesses documentation, reports, intelligence and personnel issues
- Works closely with dispatch center and county, state, and federal emergency services
- Performs assessments on department development, training and long-term goals, develops and implements policies, regulations and procedures

- Builds relationships with community
- Oversees and directs department communications and social media campaign
- Engages with citizens and assists with resolving problems
- Works daily with City Manager and closely with City Department Heads to problem solve and meet organizational goals
- Ensures compliance with state and federal mandates
- Promotes cooperation with other local, state, and federal government agencies

### **Knowledge, Skills and Other Characteristics:**

- Knowledge of community orientated policing principles and practices
- Knowledge of supervisory and management practices
- Knowledge of law enforcement practices and procedures and applicable local, state, and federal laws, rules, and regulations
- Knowledge of proper firearm handling and techniques
- Skill in developing and implementing police related policies and procedures
- Skill in analytical, objective observance of situations and quick decision making
- Skill in managing situations firmly, courteously, tactfully and impartially
- Skill in establishing cooperative work relationships
- Strong interpersonal and communication skills

## **Qualifications:**

Bachelor's degree in Criminal Justice or related field. Seven years of experience including five years supervisory experience or a master's degree in criminal justice or related field. Experience in local government and law enforcement may substitute for education. Must be or become a certified law enforcement professional in the State of South Dakota. Must live within the corporate limits of the City of Yankton within 6 months of employment.
