GENERAL PROVISIONS

INTENT:

The intent of these specifications is to describe the approximate annual quantities and the chemical composition of the various chemicals to be used for water and wastewater treatment purposes. The chemicals supplied shall meet the following minimum specifications considered necessary to adequately perform the required water treatment.

STANDARDS:

The chemicals supplied shall be of the highest standard of quality and in full compliance with the most current AWWA specifications for water and wastewater treatment and the following minimum supplementary specifications. The bidder shall include with his bid, the brand name and product composition of each chemical bid.

SPECIAL CONDITIONS:

The operation of the existing chemical feeders in both water treatment plants and the wastewater treatment plant with the product delivered will be considered in determining the best bid.

COMPOSITION OF THE BID:

The bid price shall include all labor, transportation or shipping charges and any other charges necessary for delivery of the various chemicals to the City of Yankton's water or wastewater treatment plants. Any demurrage charges will be included as a separate bid item.

The prices quoted on the bid schedule shall be firm annual quotes from January 1, 2019, to December 31, 2019, and shall be the total price as stipulated above.

BID FORMS:

All bidders must use the forms provided by the City of Yankton.

Bidders must submit completed bid proposal forms in a sealed envelope or packet clearly marked on the outside: "BID FOR WATER AND WASTEWATER CHEMICALS".

BID CLARIFICATION:

Bidders may contact the Director of Environmental Services (605) 668-5272 or (605) 668-5274 for additional clarification of these specifications.

Request for such clarification should reach the Director not later than seven (7) days before the date on which bids are due.

Prior to submission of bids, any ambiguities in the specifications shall be brought to the attention of the Director of Environmental Service. If necessary, an addendum will be issued to give effect to such clarification.

DELIVERY:

The delivery of all chemicals shall be on an as needed basis. The Department of Environmental Services, will request the quantities desired, the supplier will be required to ship the quantity of chemicals so desired and deliver the same as described in the supplemental specifications. Product delivery must be received within 7 business days.

TAXATION:

The City of Yankton shall be exempt from all Federal or state and local taxation. The City shall not be liable for additional payment to defer the cost of any tax or other imposition that might be made by Federal or state taxing authorities.

PAYMENT:

Payment for the various chemicals shall be cash upon the delivery, and acceptance of the chemicals by the City of Yankton in accordance with the following policy.

It is the policy of the City of Yankton to approve all bills on the 2nd Monday of each month and mail checks on the following Thursday. Therefore, all requests for payment must be received by the City of Yankton by the 25th day of the previous month in order to process the request on the regularly scheduled payment date. Should the request for payment be made after the dates specified payment will not be made until the following month. The contractor shall be required to include any additional costs associated with this schedule in his bid.

The undersigned bidder does hereby declare and stipulate that each proposal is made in good faith, without collusion or connection with any other person or persons bidding for the same work, and that it is made in pursuance of and subject to the general provisions and the detailed specifications, pertaining to the work to be done, all of which have been examined by the undersigned.

He agrees that the delivery will be made for a period of twelve (12) months, starting on January 1, 2019, and ending December 31, 2019, and shipments of the various chemicals bid will be as requested by the Department of Environmental Services.

All the various facets of work enumerated in the contract documents with their individual jobs and overhead, whether specifically mentioned, included by implication or appurtenant thereto, are to be performed by the Supplier under the items listed in the bid schedule, irrespective of whether it is named in said list.

The Bidder hereby agrees to commence work under this contract on January 1, 2019, and to fully provide all services and chemicals until December 31, 2019. The Bidder hereby agrees to perform all work and to supply the chemicals described in the specifications for the following amounts (Bidders have the option of bidding on any or all items specified):
